Q1. To provide details of the Proposed New Shareholders' Mandate for recurrent related party transactions and the amount of these transactions.

There are two (2) related party transactions as follows:-

For the transactions related to the provision of waste management services, the Management requested proposals for scheduled waste management services from various providers. Each proposal was evaluated by considering factors such as cost, reliability, compliance with environmental regulations, and the provider's track record. After a thorough assessment of the advantages and disadvantages of each option, the Company selected the provider that best met its criteria and needs.

Q2. Considering the completion of the new manufacturing plant, will the Company continue to rent the current plant located in Larkin?

As outlined in the Prospectus dated 15 January 2024, the new manufacturing plant is integral to the Group's expansion strategy. Following its completion, the current headquarters situated in Larkin will remain rented by the Company.

Q3. What is the current utilisation rate of the existing manufacturing plant compared to FYE2023? Can it be further improved?

The utilisation rate of the existing manufacturing plant for FYE 2023 was approximately 60%. As of the current financial year to date, the utilisation rate is approximately 65%.

It's worth noting that the plant's utilisation rate may not reach full capacity due to the presence of multiple production lines, each tailored to meet the specific product requirements of customers.
